PRIVACY POLICY

Introduction

ADECOAGRO (“We”) respect your privacy and are committed to protecting it through our compliance with this policy.

This policy (together with our terms of use and any other documents referred to in it) describes the personal information that we collect from you, or that you provide on or through adecoagro.com (our “Website”) and how that information may be used or disclosed by us.

This policy does not apply to information we collect through any other means, or to information collected on any other Company, affiliate or third-party website that may link to or be accessible from the Website. Please read the following carefully to understand our policies and practices regarding your personal information and how we will treat it. By using or accessing our Website, you agree to this privacy policy. This policy may change from time to time and your continued use of the Website is deemed to be acceptance of such changes, so please check the policy periodically for updates.

Children Under the Age of 13

Our Website is not intended for children under 13 years of age. No one under age 13 may provide any personal information to or on the Website. We do not knowingly collect personal information from children under 13. Information We Collect About You

We collect several types of information from and about users of our Website, including:

- Information you provide to us.
- Information we collect as you navigate through the site, including usage details, IP addresses [, web beacons] cookies.
- Information we receive from third parties, for example, our business partners.
- Information You Provide to Us.

We may collect and use the following information that you provide to us:

- Information that you provide by filling in forms on our Website.
- Records and copies of your correspondence (including e-mail addresses), if you contact us.

Usage Details, IP Addresses [Web beacons] and Cookies

- Usage Details and IP Addresses. As you navigate through the Website, we may also collect details of your visits to our Website, including, but not limited to, traffic data, location data, and other communication data and the resources that you access, as well as information about your computer and internet connection, including your IP address, operating system and browser type, for system administration and to report aggregate information to our advertisers. This is statistical data about our users equipment, browsing actions and patterns, and does not identify any individual.
- Cookies. For the same reason, we may obtain information about your general internet usage by using cookies. A cookie is a small file stored on the hard drive of your computer. Use of cookies help us to improve our Website and to deliver a better and more personalized service by enabling us to:

Estimate our audience size and usage patterns.

Speed up your searches.

Recognize you when you return to our Website.

You may refuse to accept cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.

We do not collect personally identifiable information automatically, but we may tie this information to your previously submitted personally identifiable information.

Uses Made of the Information

We may disclose personal information that you provide via this Website to the following third parties:

- Our subsidiaries and affiliates.
- Contractors and service providers we use to support our business.
- In the event of merger, acquisition, or any form of sale of some or all of ADECOAGRO's assets, in which case personal information held by ADECOAGRO about its customers will be among the assets transferred to the buyer.
- We may also disclose your personal information to third parties to:
 - Comply with any court order or other legal obligation.
 - Enforce or apply our terms of use and other agreements.
 - Protect the rights, property, or safety of ADECOAGRO, our customers, or others.

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:
